### **WHAT PERSONAL DATA WE COLLECT AND WHY WE COLLECT IT.**

Visitors and customers are valued by all those involved with

The Musical Rise Store Checkout process  
collects personal data from customers  
for product sales and administrative purposes  
in order to process payments, deliver products and for Purchase Receipts,  
(including product download access/details), to be emailed to the customers.  
Names and email addresses input at the Musical Rise Store Checkout  
are referenced in Purchase Receipts which are emailed to customers  
upon purchase of products.

The Purchase Receipt will not contain information  
about your IP address but will include the payment method.

PayPal payment gateway process will include  
payment details but these details are not seen or accessible  
by the Musical Rise website or manager (AJ How).

Alison receives a sales notification email to a dedicated  
Musical Rise email address which contains the customer's/  
name and email address and products purchased.  
Names and contact information will not be used for any further purpose  
unless the customer/site visitor requests further information,  
requires a response to an email they send to any of the  
Musical Rise email addresses or there is a problem  
with a product download or payment.

### **HOW WE PROTECT YOUR DATA AND PROVIDE A SECURED SITE.**

Measures have been taken to protect our users' data; technical measures including encryption; security measures include an SSL certificate. The Musical Rise website is secured with an SSL certificate; note the padlock icon in the URL address bar in your browser. Analytics are active on this website; mainly for Alison's interest regarding others' interest in the music, the products and other features. Web traffic statistics are enabled.

The regulation Cookies notice is active on the site and choices can be edited by the user upon entrance to the website pages and via the 'Cookies' link top right of the main website pages and on the NLI page.

Cookies may be used during the Checkout Process, including CART SAVING and input of required information. The 'SAVE CART' feature is for customer convenience.

The Musical Rise website was constructed by Alison with Wordpress, Elementor, Easy Digital Downloads and other plugins, including host plus featured security measures. The hosting company is Panthur (Newfold Digital as of 2022).

### **FURTHER SECURITY ~ DEVICES AND WEB BROWSERS**

Secure your website browser to Privacy mode where possible, including what is accessed by your Internet Provider and Internet Security programs.

Check microphones and cameras on your devices are not accessing/saving your passwords or financial information.

Clear browsing data or set to clear upon closing browser.

Turning off Internet connections in between usage is also good practice.

Consider running a security program scan after purchases within browsers/APPS.

If you create PDFs/print screens/snap pics during your checkout process, turn off the data to that app/program where possible, transfer the files to an offline device and delete the files from the App/Program for your security.

Avoid creating a PDF or Print Screen with your financial information in view.

When searching for a site via a search engine, avoid selecting results that have 'Ad/Sponsored' beside their reference.

This can include more cookies, tracing, tracking, fingerprinting, analytics etc.

Move down lower on the browser screen and load the page reference without the 'Ad/Sponsored' text notif often left of the website searched and found URL/Website title.

Check your bank account/financial institution statement after purchases.

**MUSICAL RISE** will be noted on your statement for purchases in the online store. Report discrepancies to PayPal, your financial institution, other relevant authorities and where necessary or applicable contact Alison via the sales email address.

As a customer/product recipient of the Musical Rise Store, the following information will be a guide as to your rights, responsibilities and obligations within our terms and Conditions of possession of the Products and further usage of the products or the musical/other material.

### **MUSICAL RISE STORE PRODUCTS** **TERMS AND CONDITIONS OF MUSICAL RISE STORE PRODUCTS** **POSSESSION/USAGE RIGHTS.**

The products in the Musical Rise Store include copyright works of those who wrote, recorded and released the material; thus made available to purchase with standard International copyright Laws.

**Products may be accessed by those intended to be the recipients in line with the quantity payment made during purchase with no further access sharing to others.**

No product is to be shared via any means to others directly or uploaded to the internet further etc. Products may be gifted to another by emailing them a copy of the purchase receipt which will contain the Product download URLs, (blank out the payment if preferred) or alternatively via a usb stick/CD or the like with reference to the Musical Rise Website and that the product is a retail item. If the buyer intends to access the files via the Purchase Receipt as well as the other recipient/s doing so, the Item Quantity input at the Checkout needs to reflect that number of people accessing the files.

Please do not email/upload the digital products.

If you intend to keep a copy of the product yourself as well as for another you need to select at least '2' in the quantity area beside the cart item.

If a product is purchased on behalf of somebody else who is paying for the product, the funds they return to you must remain the same figure as the retail cost of the item/s at the time of the initial purchase via the Musical Rise Store checkout process.

The store recordings and products may not be uploaded to any website (including YouTube/Facebook etc).

Each file is tagged with information which is accessible via various media applications/devices.
